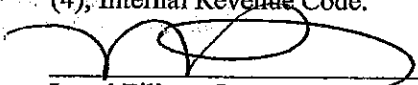
The name in the State of California of this corporation's initial agent for service of process is: **California Corporate Agents, Inc.**

IV

- A. This corporation is a nonprofit **PUBLIC BENEFIT CORPORATION** and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for Public purposes.
- B. The specific purpose of this corporation is to provide a forum for the expression and recognition of University of California graduate and professional students' needs and rights within the University of California system. Specifically, the corporation will promote the needs, rights and interests of the current and future graduate and professional student body both to the University of California and to outside entities, including legislative bodies and government agencies. In addition, the corporation will support communication, cooperation, and collaboration among individual graduate and professional student associations on each campus.

V

- A. This corporation is organized and operated exclusively for **Public** purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c)(4) of the Internal Revenue Code, or corresponding section of any future federal code.
- B. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.
- C. The property of this corporation is irrevocably dedicated to **Public** purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person.
- D. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for **Public** purposes and which has established its tax exempt status under Section 501 (c) (4), Internal Revenue Code.
